**INCREASING a PLUS LOAN**

The loan borrower must login at [studentaid.gov](http://studentaid.gov).

1. Select **“Request Direct PLUS Loan.”**
2. In the amount section, select **“Change”** and **specify a new total loan amount.**

**Important Note:** Loans cannot be increased after you cease to be enrolled at least half-time.
